Item No. 15:. To decide about payment of additional amount of body building for three

The Presiding authority informed the members that an amount of Rs. 43,16,400/was sanctioned to purchase 3 nos. Of open trucks for this Council through 14th Finance Commission grants vide Order No. 14/DMA/14th Fin/Margao/2016-17/3602 dated

Out of this an amount of Rs. 37,50,000/- was utilized to purchase cabin chassis of three trucks and amount of Rs. 5,66,400/- was balance which was to be utilized for body

After due e-tendering procedure, order for body building was issued to M/S Aspmind India at an tendered amount of Rs. 5,93,587.20/- excluding GST vide Order No. MMC/TECH/G-120/WO-2/2020-2021/91 dated 12/05/2020.

As there was delay of registration of the vehicles, the work of body building of the vehicles was also delayed. Now after the due Order from the Hon'ble Supreme Court of India, this Council was able to register the said vehicles in the month of March 2024 and after that the body building agency completed the body building of the said vehicles at the same rate as quoted in 2020 in the month of May 2024.

The agency submitted the bill on 09/05/2024 and after adding the GST the total bill amount went out to Rs. 7,00,432/- Since the amount available is Rs. 5,66,400/- the balance amount of Rs. 1,34,032/- may be paid from Municipal funds.

After brief discussion Standing Committee agreed to pay an amount of Rs. 1, 34,032/- from the Municipal funds.
